As agents for the owners, we are proud to offer for sale the timber on the following described tract.

LOCATION:

This tract is located approximately six miles east of Edenton, NC on the south side of Indian Trail Road (SR 1108) and the west Reference is made to the attached location map, sketch map, and aerial photograph for a more complete description.

SALE DATE: March 18, 2025 at 11 am at the office of Timberlands.

DESCRIPTION:

Acreage: 118 Acres (+/-)

Access: Directly off of Indian Trail Road (SR 1108) and Long Beach Road (SR 1123) as shown on the attached aerial photograph and sketch map.

Timber: Mature mixed pine and hardwood. Medium to large size pine timber and mixed hardwood species, such as oaks, yellow poplar, maple, sweet gum, etc. with overall excellent quality. An unthinned 2004 pine plantation with average quality is included in the harvest.

Boundaries: The timber sale boundaries can be identified by **BLUE & RED** paint, fields, and neighboring timber changes. Refer to attached sketch map for further clarification.

Cruise:

A single, high percentage cruise was conducted on all the merchantable timber located within the sale area. The timber information is attached. Pine and hardwood was tallied to a minimum diameter (DBH) of 6 inches. All pine products and hardwood pulpwood is quoted in tons.

DESCRIPTION cont...

Harvest: All merchantable timber is to be sold and cut within the sale area as shown in **GREEN** on the attached aerial photograph. No **BLUE or RED** painted trees are to be sold/cut. The **BLUE and RED** paint **may not** be crossed. Refer to attached location map, sketch map, and aerial photograph.

GENERAL SALE CONDITIONS:

1. Sealed bids may be mailed, e-mailed, or delivered to Timberlands Unlimited at 305 S. King Street in Windsor, NC, on or prior to **11 a.m., Tuesday, March 18th, 2025**. Bids will be opened promptly at **11 a.m., Tuesday, March 18th, 2025**.
2. Written Offer: The written offer shall have an acknowledgement of "**as advertised**" pertaining to these sale conditions and will contain a single lump sum bid to cut and remove all timber within the designated sale area.
3. The seller's agent will notify all bidders of the sale results within seven (7) days from the date of the bid opening. If sold, the sellers will sign a timber deed satisfactory to the sellers and the buyer will close the sale within 45 days after bid acceptance.
4. Terms: Cash at closing.
5. Twenty-four months (24) will be provided to cut and remove all the timber within the sale area.
6. No **RED or BLUE** painted trees are to be sold or cut. The **RED** paint **may not** be crossed. The **BLUE paint** may be crossed in the two designated locations as shown on the aerial photograph and sketch map. Refer to paragraph #7. No tops or logging debris are to be left in the paths, drainage ditches and fields. All tract roads shall be maintained and left in as good of condition as found. The buyer will be required to meet all BMP/water quality standards, and successful buyer assumes all liability under existing laws and conditions.
7. SMZ Crossing Sites: Two SMZ crossing sites are indicated on the attached aerial photographs and sketch map. These SMZ crossing sites are **not** identified on the ground. It will be the buyer's choice to locate and construct the crossing sites in this vicinity and to comply with all applicable BMP and Riparian Buffer Rules. These are the **only** areas that the **BLUE paint may be crossed**.

GENERAL SALES CONDITIONS cont...

8. All merchantable timber in the sale area (**GREEN** on photo) is to be sold/cut in preparation for reforestation. No timber of any kind is to be sold / cut outside these described boundaries.
9. Forestry Best Management Practices. The successful buyer shall follow good and accepted forestry practices generally and usually followed in the cutting and removing of the timber, and shall have the right to take all actions upon the property, which are consistent with good forestry practices and reasonably necessary to the cutting of timber. Buyer shall comply with the procedures and practices known as "Best Management Practices" as identified in the publication of the NC Division of Forest Resources or other applicable State Agencies, as hereinafter amended or revised ("BMPs"), and buyer agrees that it will comply with any and all federal, state and local laws and ordinances, rules and regulations including laws relating to the environment, water quality, river basin buffer rules and/or the handling, treatment, storage and disposal of hazardous substances, including all petroleum products.
10. The successful buyer is required to notify Timberlands Unlimited within 48 hours prior to the beginning of any and all timber harvesting activities.
11. Buyer shall observe Best Management Practices and applicable River Basin Rules, abide by North Carolina statutes on stream obstruction, water quality and sedimentation and refrain from depositing any hazardous wastes on the premises. Buyer shall hold Seller harmless from any noncompliance with the foregoing conditions and for any claim, injury or damages of any third party (including agents and employees of Buyer and its contract logger) arising from any activities conducted on the premises by Buyer.
12. Seller and Seller's Agent has provided information about the property solely for the convenience of the prospective buyer and does not guarantee or warrant map scale accuracy, timber stand information, acreage estimates, number of trees, timber volumes, or any other information.
13. The owners reserve the right to refuse any or all bids and/or reserve the right to award the timber sale in whatever manner they decide at their sole discretion to be in their best interest.

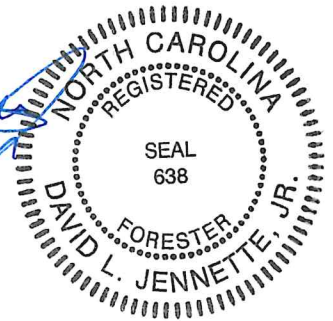
